UNIVERSITY OF KYRENIA

STUDENT SCHOLARSHIPS APPLICATION DIRECTIVE

Article 1- Purpose

The purpose of this directive is to ensure that the University of Kyrenia carries out the applications regarding the education and training scholarships within the framework of Article 5 in a proper and organised manner.

Article 2- Scope

This regulation covers how students enrolled in all educational units operating within the University of Kyrenia who are entitled to receive scholarships, financial support or tuition fee discounts can use these rights, their scope, amount, duration, application conditions and regulations regarding their expiry.

Article 3- Basis

This directive has been prepared in accordance with the University of Kyrenia Foundation and Operation Regulations, the relevant laws, regulations and by-laws of the Higher Education Accreditation and Supervisory Board (YÖDAK) of the Republic of Cyprus and the Council of Higher Education (YÖK) of the Republic of Turkey.

Article 4- Definition of Scholarship

All scholarships awarded at the University of Kyrenia within the scope of Article 5 (except in special cases) cover tuition fees only.

Article 5- Scholarship, Fee Reduction and Attendance Conditions

A- University Entrance Scholarships

Scholarships for students who are placed at the University of Kyrenia as a result of the exams conducted by the Student Selection and Placement Centre (ÖSYM) every year. In this context, there are two different types of scholarships: full scholarships and scholarships given at different rates. Full scholarship is awarded for 1 year if the preparatory school is compulsory in the programme in which the student is placed, and for the number of years of education determined by the faculty / college / vocational school. The second type of scholarships, which are given at different rates, continue throughout the education period.

ii) Students who are placed as a result of the University of Kyrenia Student Placement and Scholarship Ranking Examination are awarded scholarships at different rates. Scholarships awarded at different rates continue throughout the education period.

B- Preference Scholarships

These are additional scholarships awarded by the University of Kyrenia in addition to the scholarships awarded to students who are placed at the University of Kyrenia as a result of the exams conducted by the Student Selection and Placement Centre (ÖSYM) every year. In this context, there are two different types of scholarships. Full scholarships and scholarships given at different rates. Full scholarships are awarded for 1 year if the preparatory school is compulsory in the programme in which the student is placed, and for the number of years of education determined by the faculty / college / vocational school. Scholarships given at different rates continue throughout the education period.

C- Board of Trustees Scholarships

i) These are scholarships whose amount and duration are determined and awarded in accordance with the decisions of the Board of Trustees.

C- International Student Scholarships

i) Scholarship rates are also specified in the acceptance letters received by international students. There are two types of scholarships: full and different scholarships. Full scholarship is awarded for 1 year if the preparatory school is compulsory in the programme in which the student is placed, and at the same the number of years of education rate as institute/faculty/college/vocational school. Scholarships given at different rates continue throughout the education period. Full scholarships and scholarships given at different rates do not cover the Scientific Preparatory School or English Preparatory School.

D- Sibling Discount

i) Each of the siblings studying without a scholarship will receive a 15% discount on the programme registration fees. Students of Medicine, Dentistry and Pilotage departments cannot benefit from this discount.

E- Faculty Member Training Programme Scholarships

These are scholarships awarded to Research Assistants enrolled in graduate programmes. Details are given in the contracts signed with the students in question.

F- Personnel Discount

i)	If the staff who have completed at least 1 year in our institutions are students of Girne University, a 10% discount is applied to the programme registration fees.
