General Principles

Section One Purpose, Scope, Basis

Objective

Article 1

The purpose of this regulation is to determine the general principles regarding the obligation to wear uniforms during the education and training of the students of the University of Kyrenia Faculty of Maritime Studies, Maritime Vocational School and Faculty of Maritime Business and Management.

Scope

Article 2

This directive applies to University of Kyrenia Maritime Faculty, Maritime Vocational School and Students of the Faculty of Maritime Business and Management.

Basis

Article 3

This directive has been prepared on the basis of Articles 14 and 17 of the Higher Education Law No. 2547, the Regulation on Dress Code for Seafarers published in the Official Gazette dated 28/02/2010 and numbered 27507, the regulation published in the Official Gazette dated 20/03/2013 and numbered 28593 and the University of Kyrenia Student Discipline Regulation.

Chapter Two

Definitions and Abbreviations

Article 4

Uniform These are the official clothes that University of Kyrenia Faculty of Maritime Studies, Vocational School of Maritime Studies and Faculty of Maritime Business and Management students are obliged to wear within the university or on the training ships where they will do their internship.

Badge These are the emblems and signs to be found on the uniforms worn by the students of the Faculty of Maritime Studies, Maritime Vocational School and the Faculty of Maritime Business and Management, consisting of a badge, badge, epaulette, class, department, cap cockade and a caution.

Winter Dress Period: The period between 15 October and 15 May. The Faculty Executive Board may change the start and end dates of the winter dress period.

Summer Dress Period: The period between 15 May and 15 October. The Faculty Executive Board may change the start and end dates of the summer dress period.

Events and Official Ceremonies: It includes official ceremonies, academic meetings such as conferences, congresses and events organised on national holidays, graduation day, important days for our university and/or maritime history.

Part Three

Uniform and Signs

Uniform Obligation

Article 5

Faculty and Vocational School education and training is carried out in uniform within the scope of the Regulation on Uniforms for Seafarers and the Undergraduate and Associate Degree Regulations of the Faculty of Maritime Studies, Maritime Vocational School and Faculty of Maritime Management and Administration. It is compulsory that the clothes and signs of the students must comply with the relevant regulations and the qualifications specified in these principles.

Characteristics of the Uniform

Article 6

The characteristics of the clothes to be worn by the students during their theoretical and practical training during the winter and summer semesters and during the events and ceremonies held inside and outside the university are specified below.

1. Summer men's ceremonial attire: University of Kyrenia; Faculty of Maritime Studies, Vocational School of Maritime Studies and Faculty of Maritime Business and Management students are required to wear during the summer dress period only in official ceremonies and events specified in these principles. It is in the form of a plain, white alpaca fabric, single-front, stand-up collared gabardine jacket with five crescents and anchors, bright yellow buttons, trousers made of the same fabric, white coloured fabric woven belt and white shoes. On the shoulders of the jacket, a black fabric epaulette with a small yellow button on the collar is worn. The shape of the outfit is shown in Annex-1 Figure 1. The epaulettes bear the insignia shown in Annex-1/A, Annex-1/B and Annex-1/C.

- 2. Summer women's ceremonial dress: University of Kyrenia; Faculty of Maritime Studies, Vocational School of Maritime Studies and Faculty of Maritime Business and Management students are required to wear during the summer dress period only in official ceremonies and events specified in these principles. It is in the form of a skirt made of plain, white alpaca fabric with a single front, stand-up collar, six crescent and anchor buttons on the front left side of the jacket and buttonholes on the front right side, made of the same fabric as the jacket with bright yellow buttons and white shoes. On the shoulders of the jacket, they wear epaulettes made of black fabric with a small yellow button on the collar. The epaulettes bear the insignia shown in Annex-1/A, Annex-1/B and Annex-1/C. The shape of the uniform is shown in Annex-1 Figure 2.
- 3. Summer men's short-sleeved casual dress: University of Kyrenia; Faculty of Maritime Studies, Maritime Vocational School and Faculty of Maritime Business and Management students are required to wear during the summer dress period, except for the official ceremonies and events specified in these principles, during the use of classrooms and other educational facilities within the university during the education and training period. It consists of a white short-sleeved shirt with an open collar and a pocket on the left side without a flap, white trousers, a white woven fabric belt and shoes. On the shoulders of the shirt, he wears a black fabric epaulette with a small yellow button on the collar. The epaulettes bear the insignia shown in Annex-1/A, Annex-1/B and Annex-1/C. The shape of the outfit is shown in Annex-1 Figure-1.
- **4.** Summer women's short-sleeved casual dress: University of Kyrenia; Faculty of Maritime Studies, Vocational School of Maritime Studies and Faculty of Maritime Business and Management students are required to wear during the summer dress period, except for the official ceremonies and events specified in these principles, during the use of classrooms and other educational facilities within the university during the education and training period. It consists of a white short-sleeved shirt with an open collar, an open collar, a flapless pocket on the upper left side, buttons on the front left side and buttonholes on the front right side, white trousers, a white woven fabric belt and shoes. On the shoulders of the shirt, they wear a black fabric epaulette with a small yellow button on the collar. The epaulettes bear the insignia shown in Annex-1/A, Annex-1/B and Annex-1/C. The shape of the uniform is shown in Annex-1 Figure 2.

- 5. Winter men's and women's casual wear: University of Kyrenia; Faculty of Maritime Studies, Maritime Vocational School and Faculty of Maritime Business and Management students are required to wear during the winter dress period, except for the official ceremonies and events specified in these principles, during the use of classrooms and other educational facilities within the university during the education and training period. It is in the form of a black sweater made of woven woollen fabric, a coat made of black cashmere fabric, black trousers, black belt and black shoes. There is a flap pocket at the top of both sides of the coat. Black epaulettes with black bridges are worn on the shoulders of the coat and black jumper. The epaulettes bear the insignia shown in Annex-1/A, Annex-1/B and Annex-1/C. In winter dress, a white shirt and collar are worn and a black tie is used. The coat has a closed double front, two rows of bright yellow buttons with four crescent moons and anchors, and a slit at the back. On the right and left shoulders of the coat, he wears epaulettes made of black fabric with a small yellow button in the direction of the collar. The epaulettes bear the insignia shown in Annex-1/A, Annex-1/B and Annex-1/C. The shape of the outfit is shown in Annex-2 Figure 2.
- **6. Hat** It is made of white fabric and worn together with the clothes specified in paragraphs (a), (b), (c), (ç), (d), (e) and (f) of Article 4 of this Directive. The shape of the hat is shown in Annex-1 Figure 1 for men and Annex-1 Figure 2 for women. For the titles specified in Annex-1/A, Annex-1/B and Annex-1/C, there is a black fabric visor in front of the hat. On the upper part of the brim, for the titles specified in Annex-1/A, Annex-1/B and Annex-1/C, there is a thin tie made of yellow glaze and a small yellow button on both ends of the tie. A four and a half centimetre wide black wool strip is placed between the white upper part of the hat and the brim. A cockade is worn on this strip, in front of the brim and in the centre. The visors, ties, wool strips and cockades on the cap are shown in Annex-1/A, Annex-1/B and Annex-1/C.
- 7. Male and female work clothes: It is the clothing to be worn by all students enrolled in the course if it is determined to be compulsory by the instructor responsible for the course in applied courses. It is in the form of a plain, khaki coloured alpaca fabric, single fronted, five buttoned shirt with a turn-down collar, trousers, khaki coloured fabric woven belt and black shoes. The buttons are located on the front left side of the shirt and the buttonholes on the front right side. The shoulders of the shirt are black.

epaulettes made of fabric with a bridge. The epaulettes bear the insignia shown in Annex-1/A, Annex-1/B and Annex-1/C. The shirt has a pocket on the upper left side. A khaki labour cap is worn with this dress. A cockade is worn on the top of the cap as shown in Annex-1/A, Annex-1/B and Annex-1/C.

8. Overalls: It is the clothing to be worn by all students enrolled in the course if it is determined to be compulsory by the instructor responsible for the course in applied courses. It is made of 100% cotton and sweat absorbent fabric in navy blue colour, with sleeves and cuffs with snaps, flap pockets on the chest, stainless steel zipper on the front. Safety work shoes are worn with overalls. The shape of the outfit is shown in Annex-2 Figure 4.

Signs of Uniform

Article 7

The emblems and signs of the uniform specified in this directive are an integral part of the uniform and are specified below.

- The Badge: University of Kyrenia, Faculty of Maritime Studies and Faculty of Maritime Business and Management
 emblem and is shown in Annex 1/D. It is worn with black and white uniform.
- **2. Beç:** It is the sign shown in Annex-1/A, E- 1/B and Annex-1/C, which is worn on both collars of the jacket, explaining the departments of the students.
- **3. Epaulette:** It is the sign shown in Annex-1/A, E- 1/B and Annex-1/C, indicating the class and department of the students.
- **4.** Class Mark: It is the sign shown in Annex-1/A, E- 1/B and Annex-1/C and indicates the class of the students.
- **5. Departmental Marks:** It is the sign shown in Annex-1/A, E- 1/B and Annex-1/C indicating the academic departments of the students.
- **6. Hat Badge:** It is the yellow bright glitter embroidery on the hat that students will wear on their heads, shown in Annex-1/A, E- 1/B and Annex-1/C.
- 7. Sakındırak: It is a 1 cm wide double yellow glaze mark made of fine glaze on the hat brim with two small metal buttons on the sides, shown in Annex-1/A, E- 1/B and Annex-1/C.

Chapter Four

Carrying Uniforms

General Principles

Article 8

General Rules

- **1. Male Students:** Mustache and beard are not allowed. The haircut must be such that it does not protrude when wearing a hat, beret or cap.
- 2. Female Students: Light make-up may be worn in pastel shades. Hair can be short or long. Long hair should be gathered so that it does not exceed the jacket collar. Hair may be coloured provided that it does not contradict the uniform order. No curls or similar ornaments may be made on the forehead, temples and cheeks, and hair may not fall down.

Rules to be followed during uniform transport

Article 9

- 1. University of Kyrenia; Faculty of Maritime Studies, Maritime Vocational School and Faculty of Maritime Business and Management students are obliged to wear uniforms in accordance with the dress periods within the scope of this directive during education and training and to use the uniform in a clean, ironed and attentive manner befitting the dignity of a university student.
- **2.** Work clothes and overalls are also subject to the principles of uniform and are worn in accordance with the instructions of the instructor of the relevant course according to the content of the training.
- **3.** It is compulsory to have the signs appropriate to the department and class of the students in the uniforms. Students cannot carry emblems, signs, badges, etc. on their uniforms other than this directive.
- **4.** Pay attention to body cleanliness (daily shaving, hair, shoe cleaning, etc.) while wearing a uniform It does.

- 5. The student wears a simple, easy on the eyes briefcase-like black bag with his/her uniform.
- **6.** The uniformed student wears period-appropriate shoes under the uniform.
- 7. Students are required to wear the ceremonial attire and the hats specified in Annex-1/A, Annex-1/B and Annex-1/C. In closed spaces, the hat is removed and the student keeps it with him/her.
- **8.** There is no obligation to carry a hat in daily clothes in open spaces. Students may keep their hats with them in open or closed places in daily clothes.
- **9.** Earrings, necklaces, bracelets and rings (except school rings and wedding rings) they can't use it.

Chapter Five

Orientation, Supervision and Enforcement

Article 10

University of Kyrenia; Faculty of Maritime Studies, Maritime Vocational School and Faculty of Maritime Business and Management students are obliged to comply with this directive except in cases of excuse, and the provisions of the Higher Education Institutions Student Disciplinary Regulation are applied to those who do not comply with this directive. An instructor is assigned by the Dean to ensure the implementation of these principles in order to ensure the orientation of the 1st year students who are new to the Faculty and Vocational School to uniform dress. In cases of excuse, students can enter the courses without wearing uniforms by obtaining a signed excuse certificate from the instructor responsible for uniforms.

Enforcement

Article 11

These principles entered into force with the meeting of the University Senate dated 19.09.2019 and numbered 711. In matters not covered in these principles, the decisions of the Faculty Board and the Board of Directors are applied.

Article 12

This Directive is executed by the Rector of University of Kyrenia.




Winter Black Men's



Winter Casual Wear




Figure 3 Onthe-job




