SUMMER SCHOOL REGULATIONS

Article–1 The summer school is offered in the following faculties, colleges and vocational colleges:

Faculty of Maritime Business and Management
Faculty of Maritime Studies
Maritime Higher School
Faculty of Education
Faculty of Aviation and Space Sciences Faculty
of Economics and Administrative Sciences
Faculty of Architecture
Faculty of Engineering Faculty
of Health Sciences
Maritime Vocational College
Health Services Vocational College English
Preparatory School

- a) The academic calendar for the Summer School is determined with the approval of the Senate. Each course offered in the Summer School is conducted for the same total number of hours as in the regular academic terms.
- b) The Summer School is considered a separate semester outside of the autumn and spring semesters. Students' overall grade averages for the Summer School are assessed separately at the end of the Summer School.
- c) All facilities of Girne University are available to students during the Summer School. The library, dormitories, Innovation Centre, and laboratories are open, and students can participate in social and cultural activities.
- d) The Summer School also offers the opportunity for students from other universities to take courses.

Purpose

Article–2

- a) To enable students to retake courses they previously failed,
- b) To enable students more previous terms and at level achieved sufficient
- c) To prevent students from losing a term by ensuring they take courses, thus, on the one hand, providing failing students with the opportunity to retake the courses they failed, and on the other hand, providing successful students with the opportunity to graduate in a shorter period of time

on the one hand, and to make efficient use of idle physical resources during the holiday months on the other, and to prevent overcrowding in the Autumn and Spring terms.

Principles Regarding the Summer School

- Article–3**
- a) The undergraduate courses to be offered in the Summer School are determined by the decision of the relevant department and faculty council.
 - b) Undergraduate and associate degree students may register for a maximum of three courses totalling 12 credits during the summer school. Students may also register for courses they have not previously taken or courses scheduled to be offered in future terms during the summer school. Once courses have commenced, requests to add, change, or drop courses are not permitted during the summer school.
 - c) Attendance at courses is mandatory for students in the summer school. Students who are unable to attend examinations for a valid reason will be provided with a make-up examination. For the same reason, upon the student's request, the student's Summer School registration may be cancelled by a decision of the relevant Faculty Board.
 - d) The tuition fee for the Summer School is determined per course.
 - e) Full-time teaching staff must offer at least one course in the Summer School.
 - f) Students who take the final exam for the courses they have taken during the Summer School period and receive an FF grade in the final exam are entitled to a make-up exam for each course.

Principles for Taking Courses Outside Girne University:

- Article–4**
- a) For students to take courses from other universities during the summer term, the student's grade point average (CGPA) must be 2.0 or higher.
 - b) During a single summer term, a maximum of two courses may be taken from another university, provided that these courses are not offered at Girne University. The total number of courses taken from universities other than Girne University may not exceed five.
 - c) A course offered at Girne University during the summer school cannot be taken from another university.
 - d) The language of instruction for courses taken outside Girne University must be compatible with the programme at Girne University.
 - e) In order to take courses from another university, students must submit a reasoned request to their Department Chair at the end of the spring semester. The request must include the name and address of the university where the courses will be taken, as well as the courses and their content. After the Department Chair accepts the letter, it must be approved by the Faculty Dean. The deadline for submitting a letter to take a course from another university is the day of registration for Girne University summer school.
 - f) Students taking courses from another university must submit a transcript of the courses taken at the end of the summer school to the relevant Department Chair at Girne University.
 - g) Only grades of 2.5 or higher out of 4 from courses taken at another university are valid.
 - h) Courses that require laboratory work cannot be taken at other universities.
 - i) When taking a course from another university is confirmed, the student is obliged to pay the tuition fee set by Girne University for that term.
